2026 TOURNAMENT RULES

- Only members sanctioned through the Door County USBC Association are eligible. All tournament bowlers must have bowled 21 games in the Door County USBC last season or during the current season to be eligible to bowl in tournament.
- Handicap is 90% of the difference between entering average and 225. Any entering average of 225 and above will bowl scratch. Bowlers will use their highest USBC sanctioned average from the 2024-2025 season, based on 21 or more games. **The 15 pin rule is in effect.** If a bowler has no average from the 2024-2025 season, the highest current sanctioned average based on 21 games or more will be used. All others must bowl scratch. Tournament director will verify all averages and has right to re-rate bowlers.
- The team event will consist of 4-bowlers per team. Men, women or mixed. Bowlers may bowl and cash as often as they wish in Team Event, but need to change at least two bowlers on their team. Bowlers may also bowl and cash more than once in the doubles event with different partners. Bowlers may participate only once in singles, Bowler has to bowl singles the first time they bowl doubles. **All Events will use the first score bowled in each event.**
- Team Captains should check in 30 minutes before shift time. **All substitutes should be reported prior to date of bowling.** If any team or bowler is late, they will receive zero score for frames already finished. Protests may be made with the tournament director within 72 hours of completion of series bowled.
- All prize fees will be returned 100%. Prizes awarded in both handicap and scratch divisions.
